Roy Eriksen (PhD 1984) is Professor of English Renaissance Literature and Culture, University of Agder (Norway). He publishes and teaches in English and Italian interdisciplinary Renaissance Studies, including architectural history and theory (1400-1700). He has also published on Carducci and Robert Saviano and has translated Italo Calvino and Tomas Maldonado.

He commands English and Italian, and communicates well in German and French plus the main Scandinavian languages. Eriksen established his first Socrates in 1989 and currently has Erasmus agreements with UniCal and Marburg, and is in the process of establishing an exchange agreement with Università degli studi di Padova.

His research focuses on the relationship between Renaissance Italy and Elizabethan-Jacobean England, on issues like Tolerance and the City. Human Interacton in Social and Urban Space and cultural change as embodied in the work of Marlowe and Shakespeare and its *Verortigung* in real and fictive spaces.

Eriksen co-ordinates EMMRG, an interdisciplinary research initiative and has supervised PhD candidates in three disciplines. In addition to *The Forme of Faustus Fortunes* (Humanities, 1987) and *The Building in the text* (Penn, 2001), he has edited c. 30 books; Form and the Arts (Rome: Kappa, 2003), Ashes to Ashes (Rome: L'Ateneo, 2006), Imitation, Representation and Printing (Serra 2009).

He is Series Editor of *EMMS* (Serra, 2006–), has edited the Acta of the Norwegian Institute in Rome (Bretschneider;) and Studies in Renaissance Art and Culture (Kappa; Rome, 1998–2002); he co-*edits Early Modern Culture Online*). His Italian monograph *L'Edificio testuale* appeared in 2014 (Mimesis, Milano) Eriksen is a prize-winning urbanist.
